

COLLECTION OF DNA AT ARREST WILL BEGIN APRIL 1, 2015

A person shall provide a biological specimen to the state crime laboratories for deoxyribonucleic acid analysis if he or she meets any of the following criteria:

1. Violent Crimes as defined in [s. 165.84 \(7\) \(ab\)](#):

5. Officers shall obtain a DNA sample of any juvenile who is adjudicated delinquent for any of the following juvenile offenses that would be misdemeanors, if committed by an adult unless it is verified a valid sample is on file with the Databank:
 - a. 940.225(3m) – Fourth degree sexual assault
 - b. 941.20(1) – Endangering safety by the use of a dangerous weapon
 - c. 944.20 – Lewd and lascivious behavior
 - d. 944.30 (1m) – Prostitution
 - e. 944.31(1) – Patronizing prostitutes
 - f. 944.33(1) – Pandering
 - g. 946.52 – Failure to submit a biological specimen
 - h. 948.10(1)(b) – Exposing genitals or pubic area
